Released Parties: South Sydney District Rugby League Football Club Limited (ABN 28 002 487 390) and its directors, officers, employees, volunteers, representatives, and agents, the activity or event holders, activity or event sponsors and activity or event volunteers.

1. I assume all of the risks of participating and/or volunteering in this activity or event, including by way of example and not limited by, any risks that may arise from negligence or carelessness on the part of the Released Parties, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.
2. I certify that I am physically fit, have sufficiently prepared or trained for participation in the activity or event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems that preclude my participation in this activity or event.
3. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors and organisers of the activity or event in which I may participate, and that it will govern my actions and responsibilities at the activity or event.
4. In consideration of my application and permitting me to participate in this event, I take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:
 - a. I waive, release and discharge from any and all liability the Released Parties, including but not limited to, liability arising from the negligence or fault of the Released Parties, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may occur to me including my travelling to and from this event; and
 - b. I indemnify, hold harmless and promise not to sue the Released Parties from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by their negligence or otherwise.
5. I acknowledge that South Sydney District Rugby League Football Club Limited and its directors, officers, volunteers, representatives, and agents are not responsible for the errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity on behalf of South Sydney District Rugby League Football Club Limited.
6. I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, event monitors and/or producers of the event and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.
7. I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this activity or event.
8. By providing photo consent, I understand that at this event or related activities, I may be photographed



and/or filmed. I agree to allow my name, photo, video, image, any statement made by me or film likeness (Personal Material) to be used for any purpose by South Sydney District Rugby League Football Club Limited, the event holders, producers, sponsors, organisers, and assigns including but not limited to any advertising, promotional, educational or other material or campaign, website or online application that South Sydney District Rugby League Football Club Limited may run from time to time, for such period South Sydney District Rugby League Football Club Limited deems appropriate.

The use in clause 8 above may include associating any of the Personal Material together with any image in any medium and in any context, which advertises or promotes South Sydney District Rugby League Football Club Limited or any products or services offered by South Sydney District Rugby League Football Club Limited.
10. I agree that any use by South Sydney District Rugby League Football Club Limited of Personal Material will be without payment to me and without seeking my further consent.
11. I acknowledge that all proprietary rights including any intellectual property rights in any promotional material that includes my Personal Material (including all material adapted there from) will be owned exclusively by South Sydney District Rugby League Football Club Limited, and to the extent necessary, I hereby assign to South Sydney District Rugby League Football Club Limited any existing and future rights, including any intellectual property rights that I would otherwise have in the Personal Material or promotional material created out of it.
